**Annual 2021-22 Winter Room Safety Inspections (and abatements) have been completed.** Thanks to Mike, Kyle, Taryn, Linda, Daniel, Connie, Tom, Ryan and Karen.

**1**<sup>st</sup>**Q AED Inspections are due this month.** The completed inspection forms are to be submitted electronically to PUFD (and copy e-mailed to Tom Brown).

**KRAN Rooms 480-492 Renovation for Faculty/Staff Lounge is underway.** Floor tiles are removed and a partial wall is being removed from 480-492. Remind your staff to be safe and careful when they are near the 4<sup>th</sup> floor renovation area.

**Discussion of KRAN Main Floor AED Cabinet Placement**. Logan, Mike, and Tom met with Lt. Luse and determined the proper place for the return of the KRAN Main Floor AED cabinet (just to the right of the right-hand entrance into the Auditorium).

Fire Safety Talk by PUFD Lieutenant Kevin Luse. Lt. Luse presented an overview on General Fire Safety in Purdue Buildings on campus and in our homes. He covered safety rules to follow including using UL approved space heaters and ceramic heaters with automatic shut off features if tipped over, the safety concerns of their placement in a room and the importance of plugging directly into an electrical outlet. It is the responsibility of each of us to always turn off space heaters and fans when leaving our rooms. Additional information was provided on the proper use of powerstrips, surge protectors and home smoke detectors including the importance of filling out and mailing product registration cards and searching the internet for recalls.

DO NOT USE THE ELEVATORS. You only have a very limited time to get out of a burning building. Grab your cell phone, shut your door and exit the building in the opposite direction of where the smoke is coming from. Whenever you hear the fire alarms sounding, evacuate ASAP, DON'T use the in-wall KRAN fire extinguishers and DON't go back in the building until you are cleared to do so. We hope this talk can included in additional sessions, to which we can invite Krannert School of Management, and Agricultural Economics personnel.
