#### **LEGISLATIVE EXPERIENCE**

Drafted Virginia Senate Bill 480 in 2019, which proposed a ban on noncompete agreements for low wage workers. The bill was unique in that it also covered independent contractors, a group of workers that are usually excluded from employment laws. The bill also provided the workers with attorney fees and costs, employer required notice requirements, and a \$10,000 penalty for organizations that violate the law. Low wage was defined as the median income in the state, approximately \$68,000. The bill was signed into law and effective July 1, 2020. This is the first noncompete legislation in Virginia.

Co-drafted Illinois House Bill 1143, (1997), which proposed amendments to the Illinois Health Care Surrogate Act. House Bill 1143 was sponsored, introduced and subsequently died in Committee in late 1997. However, House Bill 1143 was used as the platform for the next Bill which was signed into law effective January 1, 1998.
